## **Membership FAQs**

### ***Who are our CFESA committee members?***

We are honored to have many great CFESA volunteers that serve on our committees. They are all great individuals that posse many great qualities such as ***Leadership, Diversity, Communication Skills, Responsible, Loyal and Strategic Thinkers.***

### ***What kind of time commitment does serving on a committee entail?***

#### **Involvement Timeline:**

Commitment is one calendar year which starts at the committee meetings held at our annual conference. You may serve on the committee for multiple years, but must re-apply at the end of your 1-year term.

#### **Time Commitment:**

Monthly conference calls and some additional monthly time will depend on which committee you serve on. In addition to the meeting held during the annual CFESA conference.

### ***What is an “Official” member on a committee?***

An “Official” member of a committee, is one that has completed an application and had it approved to join said committee to help with its projects and goals.

### ***How many “Official” members are on each committee?***

There will be 20 official members on each committee.

### ***What kind of leadership opportunities are available on a committee?***

**Leadership Opportunities:** Each committee has great leadership opportunities. A co-chair serves for a 2 year term.

### ***How does the application process work to become an “Official” member of a committee?***

You will complete the application and select your first and second choices for committees that you would like to be approved for. The applications will be reviewed by the board liaisons to that committee. They will approve you for a committee based on the skill set that you provide on your application and on availability of your first and second choices. Once you are approved you will be contacted by the committee Co-chairs.

### ***If I want to attend the committee meetings during the annual conference but am not an official member of the committee will I be allowed to attend?***

Yes, members are allowed to attend any of the meetings to listen in on what projects the committee is working on.
